Upon completion of programming and confirmation of funding, the project is anticipated to include full basic design services for removal of the existing floor, installation of a new wood athletic floor system with an interlocking airflow subfloor, and related work, including bleacher removal and reinstallation, transitions, wall base, volleyball sleeve covers, court graphics, and associated improvements.</p>
